ORDER

The Director of Local Fund Audit in his letter read above has requested to create some additional posts and upgradation of certain posts for the smooth functioning of the Department in order to cope up with the increased work load consequent on the introduction of the Panchayat and Municipalities Act and the constitution of Local Fund Accounts Committee of the Legislative Assembly.

2. Government, after having examined the matter in detail are pleased to sanction the creation of the following posts in the Local Fund Audit Department in relaxation of Economy Orders in force and following the 'New Service Procedure'.
