ORDER

As per sub-section 4 (b) of Section 3 of the Act, the Joint Examiner of Local Fund Accounts and the Deputy Examiner of Local Fund Accounts functioning as such in the Local Fund Audit Department immediately preceding the commencement of the Act shall, at such commencement be known as the 'Joint Director of Local Fund Audit' and the 'Deputy Director of Local Fund Audit' respectively. In the Kerala Local Fund Audit Rules, 1996, framed for implementing the provisions in the Act also, the designations as per the Act have been incorporated. Even though the Act came into force on 15-1-1996, the above designations still remained unchanged.

In his letter read above, the Director of Local Fund Audit has reported that for taking penal action against the officials and local body institutions who fail to produce the necessary records for audit or fail to furnish the annual

accounts within the prescribed time limit under sections 11 and 12 of Local Fund Audit Act, 1994, the designation of the various officers of the Local Fund Audit Department has to be in tune with those mentioned in the Local Fund Audit Act and Rules and has requested to issue orders re-designating the existing posts in the Local Fund Audit Department as shown below :—
